**Please read carefully; we do not want to waste your time & energy bringing items in that do not fit our policies.**

1. Payments are processed the first week of each month for monies earned the full previous month & distributed by your choice of mailing or pick up. Balances under \$5 will be carried to the next month.
2. Consignment items are accepted Monday-Saturdays of each week (with the exception of Wed. & Fri. evenings). Please watch store postings, our web site & Facebook page for any special notice of change due to holidays. Golf equipment is consigned for 90 days (season starts 3/15).
3. All equipment must be late models & in gently used condition. We reserve the right to refuse items based on its condition. You will be contacted if items later noticed to be in need of repair. Please do not be offended if we do not take all you bring in. Everyone has different judgment, but we will have the final say. We strive to offer the best quality, brands & prices for late model golf equipment. Not all items brought in may fit our store direction or target market.
4. A selling price will be determined by The Caddy Shack based on brand, quality, demand and economic conditions within our target area of Rock County. Fifty percent (50%) of the selling price of each consigned item shall be retained by The Caddy Shack and Fifty percent (50%) shall be payable to the Consignor. The Caddy Shack will try and sell your items at the best possible price, however at the discretion of The Caddy Shack, all items are subject to be reduced by 30-50% the last month of the consignment period. It is also the determination of The Caddy Shack as to how the merchandise will be displayed or marketed.
5. Consignor must pick up all unsold items within ten (10) business days from the end date of consignment. All unsold items not picked up after the end of the contract period will, WITHOUT FURTHER NOTICE, automatically become property of The Caddy Shack.
6. The Caddy Shack takes every effort to avoid damage or theft, however, we cannot be responsible for any merchandise that is stolen or damaged, including but not limited to fire or flood.
